NOTICE OF PREHEARING CONFERENCE (Set for April 23, 2024, at 9:30 a.m.)

- On November 1, 2023, Pacific Power & Light Company (PacifiCorp or Company) filed its 2024-2025 Biennial Clean Energy Implementation Plan Update (CEIP Update) with the Washington Utilities and Transportation Commission (Commission) in Docket UE-210829. The CEIP Update is required by Commission rules implementing the Clean Energy Transformation Act (CETA). The CEIP Update came before the Commission at a recessed open meeting on March 22, 2024.
- On March 25, 2024, the Commission entered Order 09, Suspending Biennial CEIP Update; Setting Matter for Adjudication (Order 09). Order 09 suspended the CEIP Update, set the matter for adjudication, and initiated an investigation.
- STATUTORY AUTHORITY: The Commission has jurisdiction over this matter under Title 80 Revised Code of Washington (RCW) and has legal authority to regulate electric companies. The statutes that apply to this matter include Chapters 80.01 RCW, 80.04 RCW, and 19.405 RCW, including but not limited to RCW 80.01.040, RCW 80.04.020, RCW 19.405.060. The rules that apply to this matter include those within Chapter 480-100 WAC, relating to electric companies.
- The Commission will hear this matter under the Administrative Procedure Act (APA), particularly Part IV of Chapter 34.05 RCW relating to adjudications. The provisions of the APA that relate to this proceeding include, but are not limited to RCW 34.05.413, RCW 34.05.422, RCW 34.05.431, RCW 34.05.440, RCW 34.05.449, and RCW 34.05.452. The Commission will also follow its procedural rules in WAC 480-07 in this proceeding.

- The purpose of the prehearing conference is to consider requests for intervention, resolve scheduling matters including establishing dates for distributing evidence, to identify the issues in the proceeding, and to determine other matters that will assist the Commission in resolving the matter, pursuant to WAC 480-07-430.
- INTERVENTION: Persons who wish to intervene should file a petition to intervene in writing at least three business days before the date of the prehearing conference. See WAC 480-07-355(a). The Commission will consider oral petitions to intervene during the conference, but strongly prefers written petitions to intervene. Party representatives must file a notice of appearance with the Commission no later than the business day before the conference. See WAC 480-07-345(2). Any party or witness in need of an interpreter or other assistance should fill out the form attached to this Notice and return it to the Commission. The Commission will set the time and place for any evidentiary hearings at the prehearing conference, on the record of a later conference or hearing session, or by later written notice.]
- THE COMMISSION GIVES NOTICE That any party who fails to attend or participate in the prehearing conference set by this Notice, or any other stage of this proceeding, may be held in default under RCW 34.05.440 and WAC 480-07-450.
