That sounds accurate; since we're not running the Downtown Airporter as a stand-alone service right now, we are lumping all trips in all vehicles (with the exception of chartered buses that pick up at 00) into the higher "All Other" rate. I do see that there have been a number of times when passengers for door-to-door/scheduled/DTA services were grouped together into a single vehicle that has a total passenger count greater than 10. These trips used some of our buses or 14 passenger shuttles to take the passengers to downtown Seattle/Bellevue and due to the height restrictions inside the garage would have needed to pick up at island 2 instead of directly at the curb.

With cruise season starting tomorrow, I'd expect to see more buses picking up at island 2 for the shared-vehicle services (non-charter), and we will continue to report those on the monthly report as we have in the past at the \$3.27 rate per-trip. If you have any concerns about which vehicles are picking up at island 2, or if any procedures/processes need to happen or change that aren't currently, please feel free to let me know and I'll pass along to our operations team to address immediately.
