The purpose of this filing is to comply with the Commission's Order 09 in Docket Nos. UE-121697 and UG-121705 (consolidated) ("Order 09") and Order 08 in Docket Nos. UE-130137 and UG-130138 (consolidated) ("Order 08"). Orders 09 and 08 together are referred to herein as the "Order".

As discussed in paragraphs 14 through 33 of the Order, the Joint Parties-Electric proposal modifies the decoupling mechanism (Schedule 142) for Schedules 26 and 31 and makes an adjustment to the base rates for Schedules 26 and 31 as well as the Schedule 141 (Expedited Rate Filing Rate Adjustment) rates for Schedules 26 and 31. The changes to Schedule 142 added two sheets and resulted in this filing including all sheets in Schedule 142.

The tariff sheets described herein reflect an issue date of December 19, 2013, and an effective date of January 1, 2014. This tariff filing is a compliance filing and no additional notice was required. The proposed tariff sheets will be posted, as required by WAC 480-100-193, on the PSE web site immediately prior to or coincident with the date of this transmittal letter in accordance with WAC 480-100-193(1).
