

TREATMENT ASSESSMENT

A. Applicable:

To all customers receiving service on the Alder Lake Water System.

B. Flat Rate Assessment: \$3,405.00

C. Assessment Over Time:

Customers choosing this option would sign a promissory note for the amount of \$3,405.00 payable in monthly installment over ten years with interest at eleven percent. Lender is charging loan origination fee of between three to five percent. Lender is a third party, unrelated to Company.

D. Conditions:

1. The customer may choose whether to pay the assessment as a flat rate assessment or an assessment over time. Customers must exercise their choice within thirty days of the effective date of this Schedule.

Iliad Water Services, Inc. has filed for approval from the Washington Utilities and Transportation Commission (Commission) to put into place a water system improvement and treatment assessment for the Alderlake water system.

To keep the water system in compliance with the regulations of the Department of Health the water company will be required to install facilities improvements in accordance with approved construction documents per Department of Health W.A.C. 246-290-120 and the installation of treatment improvements per Department of Health W.A.C. 246-290-451 and 246-290-640.

At the customer's choice, the customer would pay either a flat rate assessment of \$3,405.00 or pay monthly installments over ten years with interest at eleven percent under a promissory note. For those customers that choose payment over time, there would also be a loan origination fee of between three to five established by the lender at the time the loan is made. Installment payment on a note would be approximately \$50.00 per month.

If approved by the Commission, the proposed water system improvement and treatment assessment will become effective when construction has been completed and approved by the Washington Department of Health.

The reason for the filing is to raise the money to fund the improvements for Department of Health Compliance. If you have questions about the proposed filing and how it will affect you, please call Iliad Water Services dba Alderlake Water Company at (800) 928-3750.
