I write as a follow-up to our recent discussions regarding the dismissal of Hungry Buzzard Recovery, LLC ("Hungry Buzzard"), from the above-referenced proceedings.

As we have discussed, Hungry Buzzard no longer engages in the activities which are the subject of the above-referenced proceedings. Enclosed is a statement from Hungry Buzzard which explains the scope of its current operations. Nevertheless, Hungry Buzzard is willing to abide by the final decision reached in the above-referenced proceedings and any appeal taken therefrom. Please advise as to the Commission's position with respect to a stipulation dismissing Hungry Buzzard from the above-referenced proceedings.

Although I understand that Commission Staff may request additional information regarding Hungry Buzzard's current operations, such an inquiry is far beyond the scope of the current proceedings and would constitute nothing more than a fishing expedition.

Hungry Buzzard Recovery sorted material at its facility in Mill Creek from March 2006 until January of 2008. Hungry Buzzard sorted the streams of wood, concrete, asphalt, cardboard, sheetrock, metals, sheet plastics and carpet pad. Hungry Buzzard accomplished its sorting by trac hoe, loader and personnel on the ground.

Hungry Buzzard shut down its' operations and awaits a decision from a Snohomish County hearing examiner. A determination is being rendered whether the "sorting" activity is permitted outright or whether it requires a conditional use permit. Hungry Buzzard is in possession of correspondence from the county that specifies that the use was permitted outright.

Hungry Buzzard is currently sending its materials directly too Pacific Topsoils, United Recyclers, Glacier Recycling, CDL Recycle, Renton Concrete Recyclers, American Roofing Recyclers and Fruhling for ultimate recycle of material. Hungry Buzzard sends no material to Weyerhaueser currently.
