This filing is submitted by: Freedom 2000 LLC DBA Cando Recycling and Disposal

Docket number TG-081576 has been assigned to the original application of Freedom 2000 LLC which was submitted on August 26, 2008.

Since that application and a subsequent prehearing conference as well as status reports; consolidated dockets TG-080913; TG-081089; and TG- 082129, have culminated in the Commission ordering Points Recycling and Refuse, LLC's request to cancel their solid waste certificate G-155 effective July 1, 2009; and the consolidated dockets closed.

This brings to light that Docket TG-081576 was for curbside recycling only, and was put forth due to Points Recycling and Refuse, LLC's discontinuation of and refusal to reinstate such services in contravention of Whatcom County Code and previous attempts to have the WUTC amend Points Recycling and Refuse, LLC's tariff, removing those services.

Given these two circumstances, and in view of the statement posted on the Washington Utilities and Transportation Commission's Website; "*The Washington Utilities and Transportation Commission (UTC) is seeking applicants to provide either temporary or permanent refuse collection and recycling services as specified by Whatcom County's Comprehensive Solid Waste Management Plan*" Freedom 2000 LLC is submitting an amended application to provide all services previously provided by Points Recycling and Refuse, LLC, including the curbside recycling component which they discontinued in early 2008.

It is our understanding that this amended application may be included in Docket number TG-081576, but that due to the amendments, a new 30 day notice for protests will be required. We are in receipt of correspondence from Judge Friedlander dated June 19th 2009 that indicates an interest in our intentions given the current circumstances, and in inclination to proceed with the July 6th, 2009 status hearing scheduled for 1:30 PM. We trust that those intentions are made clear with the submission of the attached application and related documents and await the Commission's direction in this matter.


The new amended application complete with tariff provides:
