Pursuant to FCC requirements as clarified in: *Wireline Competition Bureau Announces Filing Deadline of July 2, 2012, for Eligible Telecommunications Carriers To File Reports Pursuant to Section 54.313(a)(20) Through (a)(6) of the Commission's Rules*, WC Docket No. 10-90, et al., Public Notice, DA 12-729 (rel.
