The administrative rules at issue are WAC § 480-07-340, -355.

Boise manufactures and distributes paper products in the United States, including sheet papers, containerboard and corrugated containers, and market pulp. Boise is Pacific Power & Light Company's ("Pacific Power" or the "Company") largest customer in Washington, purchasing both power and power delivery services at its mill in Wallula, Washington. Boise was a party to Pacific Power's most recent power cost adjustment proceeding, Docket UE-170717, as well as the Company's last general rate case, Docket UE-152253.

On September 13, 2018, Pacific Power filed a request to implement the revised depreciation rates set forth in its updated depreciation study. Any adjustment to such rates will

substantially and directly affect Boise. Accordingly, Boise requests leave to intervene in this

proceeding to represent its interests which are directly affected by Pacific Power's application.

Boise's legal counsel and expert have extensive experience in proceedings before

the Commission involving Pacific Power tariffs, rules, and rate schedules. Boise has participated

in several Company proceedings, most recently including UE-140762, U-151958, UE-152253,

UE-161204, and UE-170717. Boise's intervention in this proceeding will assist the Commission

in resolving the issues and will not unreasonably broaden the issues, burden the record, or delay

this proceeding.
