TO ALL INTERESTED PERSONS:

The Washington Utilities and Transportation Commission (Commission) will accept comments on Cascade Natural Gas' (Cascade or Company) final integrated resource plan for natural gas service. Per [WAC 480-90-238](#), an "integrated resource plan" (IRP or Plan) means a "plan describing the mix of natural gas supply and conservation designed to meet current and future energy demands at the lowest reasonable cost to the utility and its ratepayers." Cascade filed its final IRP on February 24, 2023.

Per [WAC 480-90-238\(5\)](#), the Commission will hear comments on Cascade's final IRP at an open public meeting. Cascade representatives will present the final Plan to the Commission and respond to questions from the Commissioners and the public at a recessed open meeting of the Commission to be held on **Thursday, June 1, 2023, at 9:30 a.m.**

The Commission will be holding the meeting virtually. Commission headquarters will not be open to the public for in-person participation. Interested persons may comment on the plan at the
