TO ALL PARTIES:

On February 19, 2020, Puget Sound Energy (PSE or Company) filed with the Washington Utilities and Transportation Commission (Commission) an Application for an Order Authorizing the Sale of All of PSE's Interests in Colstrip Unit 4 and Certain of PSE's Interests in the Colstrip Transmission System (Application).

On March 13, 2020, the Commission held a prehearing conference in this matter. On March 23, 2020, the Commission entered Order 02, Prehearing Conference Order, which, among other things, established a procedural schedule.

On July 9, 2020, the Commission issued a Notice Suspending Procedural Schedule until PSE filed its supplemental Application.

On August 20, 2020, PSE filed with the Commission its Supplemental Application.

On August 24, 2020, the Northern Cheyenne Tribe filed with the Commission a late-filed petition to intervene (Petition).

The Commission determines that it is necessary to hold a second virtual prehearing conference for the purpose of resolving scheduling matters including establishing dates for distributing evidence, identifying the issues in the proceeding, considering the Northern Cheyenne Tribe's late-filed petition to intervene, and determining other matters to assist the Commission in resolving the matter, as listed in WAC 480-07-430. Accordingly, the Commission will hold a second virtual prehearing conference in this matter using Microsoft Teams. The second virtual prehearing conference will be held on Tuesday, September 8, 2020, at 11:30 a.m.
