(a) "Annual Gas Bill" is calculated from Cascade's Revised Response to UTC Staff Data Request No. 96C (confidential) (full 12-month bills). The high usage is defined as average consumption plus two standard deviations.

(b) For the purpose of LIHEAP calculation, "Annual Gas Heating Bill" is calculated as total annual gas bill minus base load (lowest monthly consumption). Heating bill as a percentage of annual bill is calculated based on Cascade Response to UTC Staff Data Request No. 24C (confidential).

(c) "LIHEAP Support" is calculated based on Gas Heating Bill and the LIHEAP Benefit Curve.

(g) "WEAF support" amount is calculated as 30% or 50% of the annual bill, assuming the discount can be applied to all bill line items. If WEAFF discount cannot be applied to the temporary adder schedule rates, the support amount will be reduced by about 5%.

(k) and (m) "Average Income" per household is based on published 2017 Federal Poverty Guidelines: <https://liheapch.acf.hhs.gov/news/july16/FPG.htm>
