On September 23, 2020 and October 15, 2020, Puget Sound Energy ("PSE") filed with the Commission revisions to its Tariff WN U-60, Tariff G, Electric Service, and Tariff WN U-2, Natural Gas, to comply with the portion of the Commission's Order 8, Final Order Rejecting Tariff Sheets; Authorizing and Requiring Compliance Filing, modified by the Commission's Order 10, Granting Motion for Clarification, Order 11, Other Order; Granting Motion to Extend Compliance Filing Deadline, and Order 12, Accepting Electric Compliance Filing, in consolidated Dockets UE-190529 and UG-190530 ("2019 GRC dockets").

This filing is being made consistent with the Commission's Order 14 and other Modified Orders, in newly consolidated Dockets UE-190529, UG-190530, UE-190274, UG-190275, UE-171225, UG-171226, UE-190991, UG-190992, UE-200843, and UG-200844 ("Modifying Order") that addresses electric rates, wherein the Commission approved the tariff sheets PSE included with a filing it made on August 27, 2021, and ordered the tariff sheets to become effective by operation of law on October 1, 2021. PSE is submitting a separate filing of its natural gas tariff sheets also consistent with the Commission's Order 14 and Modified Orders under the Company's Advice No. 2021-29. The attached revised electric tariff sheets reflect the form and rates authorized by the Modifying Order and were previously included as exhibits with PSE's August 27, 2021 filing.

The enclosed revised tariff sheets provide minor changes from the exhibits that were filed such as to make minor wording changes and to reflect issue dates of September 29, 2021, and effective dates of October 1, 2021 by authority of Order 14 of the Washington Utilities and Transportation Commission in Dockets UE-190529, UG-190530, UE-190274, UG-190275, UE-171225, UG-171226, UE-190991, UG-190992, UE-200843, and UG-200844 (consolidated). Posting of these tariff changes for public inspection and review, as required by law and the Commission's rules and regulations, is being completed in accordance with WAC 480-100-193(1).

Finally, prior to the issuance of Order 14, PSE made a filing in compliance with Orders 08 and 10 under Dockets UE-210676 and UG-210677. The sections under which the filing was made

were subsequently removed in Order 14. Therefore, PSE will be withdrawing the filing before its November 1, 2021 effective date.
