Per WAC 480-07-883, the Commission's final order requiring a compliance filing will include the effective date for tariff sheets required as part of the compliance filing. No effective date was prescribed in Order 06 or Order 08 for the tariff revisions, therefore the Company respectfully requests an effective date of January 1, 2018.

Pacific Power makes this filing in compliance with Order No. 6, Docket No. UE-161204 (Oct. 12, 2017) (the Order). Pacific Power initiated this proceeding to clarify existing tariff rules governing permanent disconnections from its system. The revisions were needed to address a long-standing, and continuing problem, in portions of Pacific Power's Washington service territory that are not governed by a territory allocation agreement with neighboring utilities.

In the Order, the Commission accepted in part, and denied in part, Pacific Power's requested tariff revisions. The Commission instructed Pacific Power to work cooperatively with Commission Staff and intervenors on two specific issues: (1) procedures for resolving disputes between Pacific Power and departing customers over stranded cost recovery fees; and (2) language governing decommissioning electric facilities in place when removing them would cause operational or safety issues.

Pacific Power, Commission Staff, and intervenors in the docket worked cooperatively to address the two issues identified by the Commission. The parties exchanged numerous drafts and participated in multiple conference calls in an effort to resolve disagreements and minimize contested issues in this compliance filing. As a result, the parties resolved many of the contested issues, and the rules in this compliance filing reflect compromise on the part of all parties. Pacific Power appreciates the thoughtful comments provided by Staff and intervenors.

There are, however, certain issues that remain unresolved. For example, Staff has taken the position that every stranded cost recovery fee must be submitted to the Commission for review and approval. Pacific Power disagrees that the Order compels that result, and has proposed a construct where stranded cost recovery fees for large departing customers (1 MW and greater) will be submitted to the Commission for review and approval. While the parties agree on the general contours of the dispute resolution provisions, there are some disagreements over the finer points of the procedures.

Another disputed issue involves the proposed language governing decommissioning facilities in place. Columbia Rural Electric Association believes that there are no circumstances where a customer would not either purchase, or seek to have the facilities removed at the customer's expense. Pacific Power disagrees and believes that the rules should provide the utility with flexibility to address circumstances that present operational or safety issues.

Pacific Power understands that Staff and intervenors will provide comments to the Commission specifying their concerns with the compliance filing. Pacific Power reserves the right to respond to any such comments.
