# Local Sales, Use Tax Rates and Changes

Effective April 1 - June 30, 2016

## Local sales/use tax changes

(Effective April 1, 2016)

### City of Centralia

Sales and use tax within the City of Centralia will increase two-tenths of one percent (.002). The tax will be used for transportation services.

### Clallam County

Sales and use tax within Unincorporated Areas of Clallam County will increase two-tenths of one percent (.002). The rate change reflects an increase of .002 for the optional sales tax.

### City of Clarkston

Sales and use tax within the City of Clarkston will increase two-tenths of one percent (.002). The tax will be used for transportation services.

### City of Enumclaw

Sales and use tax within the City of Enumclaw will increase one-tenth of one percent (.001). The tax will be used for transportation services.

### Pacific County

Sales and use tax within all of Pacific County will increase one-tenth of one percent (.001). The tax will be used for emergency communication.

### City of Shelton

Sales and use tax within the City of Shelton will increase two-tenths of one percent (.002). The tax will be used for transportation services.

### Snohomish County

Sales and use tax within Unincorporated P.T.B.A. areas and certain cities of Snohomish County will increase three-tenths of one percent (.003). The tax will be used for transportation services.

### City of Tacoma

Sales and use tax within the City of Tacoma will increase one-tenth of one percent (.001). The tax will be used for transportation services.

## New feature allows you to print your reseller permit

Misplaced your reseller permit? No worries. The Department has simplified the process for businesses to view or print their reseller permit, which allows approved retailers and wholesalers to purchase items for resale without paying sales tax.

You can now access your reseller permit through "My Account." Simply log into "My Account" under "Manage Account," click on "Apply/view status of Reseller Permit" to access a copy of your reseller permit.

Prior to adding this feature, a business needing its reseller permit had to contact the Department and ask for a reprint to be mailed.

## 50% penalty – misuse of reseller permits

If your business has a reseller permit, you may only use it to purchase items for resale. Do not use it for personal or household items, promotional gifts or materials and contract labor for speculative construction. Your business must make sure that either sales or use tax is paid on all consumable purchases. The Department routinely verifies proper use of reseller permits; misuse of a reseller permit could result in a 50% penalty on the underpayment or a possible revocation of the permit. We send important messages to you through the secure messaging system in My Account—including time sensitive notices such as assessments, tax rate changes and delinquency notices. The secure system then sends you an email, letting you know you have a message.
