Description of amendment: Amends the agreement to set out provisions with regard to Internet Traffic.

The amendment amends the interconnection agreement between Verizon Northwest Inc. and Focal Communications Corporation of Washington established pursuant to WUTC Docket No. UT-013019 and assigned by Focal Communications Corporation of Washington to Broadwing Communications, LLC.

Company A represents that the amendment does not discriminate against non-party carriers, that it is consistent with state and federal law, and that it is in the public interest.
