Westgate Communications LLC d/b/a WeavTel (the "Company") hereby submits the following reports in accordance with WAC 480-123-070 and WAC 480-123-080.

Report 1: WAC 480-123-070(1)(a): The Company was not in operation during 2005.

Report 2: WAC 480-123-070(1)(b): The Company was not in operation during 2005.

Report 3: WAC 480-123-070(4): The Company was not in operation during 2005.

Report 4: WAC 480-123-080(1)(b): Attached is the pro forma which was used for the revenue objective computation for the Company. The Company's revenue objective was not accepted by the WUTC and determination of the revenue objective was set for hearing by the Commission at its July 26, 2006 open meeting. The Company has invested in switch and outside plant facilities in order to serve the Stehekin exchange. This is the basis the Company expects to use to request federal high-cost support.

<u>Report 5</u> WAC 480-123-080(2): The Company has installed switching and outside plant facilities which allows it to provide service for the very first time to the Stehekin area. If additional funds are necessary to provide services these will be invested in 2007.
