1 Pursuant to the Notice of Item to be Heard at the Washington Utilities and Transportation Commission's ("Commission") Regularly Scheduled Open Meeting and Notice of Opportunity to File Written Comments ("Notice"), the Alliance of Western Energy Consumers ("AWEC") hereby submits these Comments in response to the Joint Application of Puget Sound Energy ("PSE") and the Ontario Teacher's Pension Plan Board and Macquarie Washington Clean Energy Investment, L.P. ("Purchasers") (collectively "Joint Applicants").

2 AWEC has reviewed the *Joint Application*, including the Purchase and Sale Agreement, the Amended LLC Agreement, and the Commitments of the Joint Applicants, as well as responses to informal data responses provided by the Joint Applicants. Additionally, AWEC has participated in multiple discussions with the Joint Applicants and other stakeholders, including Staff, Public Counsel, and The Energy Project, regarding the *Joint Application* and the updated Commitments of the Joint Applicants, filed with the Commission. At this time, AWEC has not identified any issues of concern or objections to the proposed transaction as outlined in

the *Joint Application* and supporting materials, including the updated Commitments of the Joint Applicants. AWEC continues to engage the Joint Applicants and other stakeholders in discussions regarding the proposed transaction, and will supplement these Comments, if necessary, during the Commission's scheduled open meeting.
