Under date of July 3, 1985 this Commission issued an Order Granting Application in the above Cause. It contained two minor errors, which should be corrected herein. Under FINDINGS OF FACT 1. it should be corrected to read:

"1. Washington Natural Gas Company, a Washington corporation, operates a gas plant for hire in this state and is subject to the jurisdiction of this Commission."

In the APPENDIX A-20 - LEGAL DESCRIPTION - SNOHOMISH AND KING COUNTIES should be corrected to read as follows:

"Beginning at the northwest corner of Section 17, T. 27 N., R. 7 E.; thence east along the north line of Section 17 extended to the northeast corner of Section 13, T. 27 N., R. 7 E.; thence south along the east line of Section 13 extended to the southeast corner of Section 36, T. 25 N., R. 7 E; thence west along south line of Section 36 extended to the southwest corner of Section 33, T. 25 N., R. 7 E.; thence north along the west line of Section 33 extended to the southeast corner of Section 5, T. 25 N., R. 7 E.; thence north along the of Section 5 extended to the southeast corner of Section 5, T. 25 N., R. 7 E.; thence west along the south line of Section 5 extended to the southwest corner of Section 2, T. 25 N., R. 6 E.; thence north along the west line of Section 2 extended to the northwest corner of Section 2, T. 26 N., R. 6 E.; thence east along the north line of Section 2 extended to the southwest corner of Section 32, T. 27 N., R. 7 E.; thence north along the west line of Section 32, T. 27 N., R. 7 E.; thence north along the west line of Section 32; to the point of beginning."

All other information contained in the Order Granting Application remains the same.
