Status of Compliance of Companies Named in Notice of Intent to Cancel Certificate

Dear Mr. Johnson:

On October 15, 2018, the Commission served a Notice of Intent to Cancel Certification as a Charter and Excursion Carrier and Opportunity to Request a Hearing (Notice) on 36 charter and excursion carrier companies that failed to file an annual safety report and/or pay the annual regulatory fee. The Notice stated that the Commission would cancel each company's certificate unless, within 30 days, the company (1) came into compliance with applicable law by submitting the delinquent annual safety report and paying the required regulatory fee or (2) requested a hearing to demonstrate why the company's certificate should not be canceled.

More than thirty days have now elapsed since service of the Notice. As of December 17, 2018, 18 companies have come into compliance. Because these companies are now in compliance the Commission need not cancel their certificates. Additionally, nine companies have closed. The remaining nine companies still have not filed a 2017 annual report and/or paid 2018 regulatory fees.

Attached is a table showing the compliance status of all of the companies that received the Notice. Staff recommends that the Commission cancel the certificates of those nine companies that remain out of compliance with the Commission's annual safety report and regulatory fee submission rules.
