# TELECOMMUNICATIONS SERVICES AGREEMENT BETWEEN

#### VERIZON SERVICES ORGANIZATION INC.

AND

MCI COMMUNICATIONS SERVICES, INC.

This Amendment 33 to the Telecommunications Services Agreement (Contract No. TSA010302-1) (Agreement) by and between MCI Communications Services, Inc. d/b/a Verizon Business Services, a Delaware corporation, with offices at 6929 N. Lakewood Avenue, Tulsa, Oklahoma 74117 ("Provider"), and Verizon Services Organization Inc., a Delaware corporation, with offices at 6665 N. MacArthur Boulevard, Irving, Texas 75039 ("Customer") shall be effective on the date set forth below.

#### 1. EFFECTIVE DATE

This Amendment 33 shall be effective upon full execution by both parties.

#### AGREEMENT MODIFICATION

- 2.1 ADD a new Subsection 48.4.1(vi) to Exhibit C as follows:
- "(vi) With respect to calls associated with FTNA (as such calls are described in Subsection 48.2.4), Provider may bill Customer for all additional charges Provider (or its affiliates who may be used to provide the SIP GATEWAY Service) is itself billed by third-party carriers for the origination, transport and termination of Gateway Local Service FTNA calls (including (i) any charges which such third-party carriers backbill Provider or (ii) any amounts Provider may pay to such third-party carriers in settling disputes related to FTNA calls), and Customer agrees to pay such additional charges in accordance with the billing provisions of this Agreement. Following Customer's payment of such additional charges and upon Customer's request, unless contractually prohibited Provider agrees to assign to Customer Provider's rights to dispute, challenge and/or seek a refund of such additional charges paid by Customer. Subject to any contractual or other restrictions relating to the nondisclosure of confidential information, Provider agrees to use good faith efforts in providing Customer, as soon as commercially possible, written notice of any charges or amounts for which Customer may be required to pay Provider as described in this subpart (vi). Upon Provider's request, Customer agrees to cooperate with Provider and make its call detail records, billing systems and other necessary information reasonably available to Provider solely for the purpose of identifying FTNA calls and determining the physical location from which FTNA calls originate or to which FTNA calls terminate. Provider may suspend or cancel Gateway Local Service without liability to Customer if any governmental authority promulgates or issues any law, rule, regulation, arbitration decision or other order that detrimentally and materially affects Provider's costs in providing Gateway Local Service as described herein, or if Provider reasonably determines that such suspension or cancellation is required to prevent or forestall imposition of such action by a governmental authority. Provider agrees to give Customer notice as soon as

commercially reasonable of any potential or actual suspension or cancellation as allowed hereunder."

- ADD a new Subsection 48.4.7 to Exhibit C as follows: 2.2
  - "48.4.7 Provider's SIP Gateway and Carrier IP Term SIP Interstate usage charges are subject to the following discount schedule and shall be effective on the first day of the first full billing cycle following full execution of Amendment 33. Contributing monthly revenue will include switched long distance (Carrier IP Termination SIP - ABB) and the following SIP Gateway usage charges: SIP Local Outbound Usage Charges, SIP Long Distance Usage Charges, SIP Local & Long Distance DA Usage Charges, SIP Operator Services Usage Charges, SIP 1-800-COLLECT Usage Charges, and SIP Inbound Usage Charges.

- 3. OTHER TERMS AND CONDITIONS

Except as specifically amended herein, the terms and conditions of the Agreement, including any Amendments thereto, shall remain in full force and effect during the term of the Agreement.
