TO ALL PARTIES:

On November 19, 2020, the Commission entered Order 04, Prehearing Conference Order; Notice of Brief Adjudicative Proceeding (Order 04) in this matter. Order 04, Among other things, set time for a virtual brief adjudicative proceeding (BAP) on January 22, 2021, at 1:30 p.m. and set the deadline to file exhibits and exhibit lists at 5 p.m. on January 15, 2021.

On January 4, 2021, Paul Henrickson, d/b/a Concrete and More, (Concrete and More) contacted Commission staff (Staff) and the former presiding officer, requesting a continuance of the BAP to allow time for Concrete and More to receive and review the outstanding response to its request for Commission records. Staff responded that it does not object to the request.

The current presiding officer, Administrative Law Judge Gregory J. Kopta, requested via email that the parties work together to establish a mutually agreeable time for the rescheduled BAP during the week of February 22, 2021. Neither party responded. Having received notice of neither conflicts nor suggestions, the Commission finds good cause to schedule the BAP on Thursday, February 25, 2021, at 1:30 p.m.
