5 **Q. Please state your name and business address.**

6 A. My name is Ronald J. Roberts. My business address is 355 110th Avenue NE,  
7 Bellevue, Washington 98004.

8 **Q. By whom are you employed and in what capacity?**

9 A. I am employed by Puget Sound Energy (“PSE”) as Vice President, Energy  
10 Supply.

11 **Q. What are your duties as Vice President, Energy Supply?**

12 A. As Vice President, Energy Supply, I am responsible for (i) generation and natural  
13 gas storage, (ii) generation and transmission development, (iii) load serving  
14 operations, and (iv) the energy supply merchant function.

15 **Q. Briefly describe your training and relevant employment experience.**

16 A. I have over 30 years of experience in the electric utility, chemical, construction,  
17 and mining industries with specific expertise in utility management, engineering,  
18 project management, construction, operations and maintenance.

19 Prior to joining PSE in October 2010, I was Manager of Operations and Manager  
20 of Power Generation for PPL Montana in Colstrip, Montana. As such, I was  
21 responsible for planning, engineering, and budgeting for the four unit generating

1 station at the Colstrip Stream Electric Station, which included capital  
2 improvement projects, engineering, and operation and maintenance of the  
3 generating assets.

4 Prior to joining PPL Montana, I was the Environmental Health and Safety  
5 Manager and Construction Manager for Agrifos Fertilizer in Pasadena, Texas.

6 I also worked for over 16 years in a variety of engineering, project management,  
7 and environmental management in the mining industry.

8 I graduated from the Colorado School of Mines with a Bachelor of Science in  
9 Mining Engineering with a minor in Economics.
