TO ALL PARTIES:

The Washington Utilities and Transportation Commission (Commission) is reviewing the parties' pending motions and requests clarification on the applicability of Qwest Corporation's access tariff(s) to the parties' interconnection agreements (ICAs).

In their motion for summary determination, Pac West Telecomm, Inc. (Pac-West) and Level 3 Communications, LLC (Level 3) assert that "a review of Qwest's interstate access tariff demonstrates that it does not apply to the traffic at issue" or "depict the serving arrangements applicable to VNXX ISP-bound traffic." In response, Qwest Corporation (Qwest) contends that Pac-West and Level 3 "ignore completely that the ICAs contain express language referring to and incorporating Qwest's tariffs" but Qwest does not directly cite to this incorporating language. Elsewhere, Qwest's response does cite to its ICAs with Pac-West and Level, but not for this same assertion. The Commission asks Qwest to clarify this point by producing the express language, if any, in its interconnection agreements that refer to and incorporate Qwest's tariffs.
