- a. Avista does not have a forecast of EIM exports. In 2023 and 2024 through April, Avista dispatched 5.2% of its generation for export. See the confidential file “PC-DR-308C Confidential Attachment A - AvistaEIMExports.xlsx” for the data and calculations used in this response. The EIM transactions shown in the spreadsheet are sourced from our Energy Trade and Risk Management software package Nucleus where all EIM transactions are recorded, and specifically from our CCATAGMW table used to organize our transactions in support of Washington’s Climate Commitment Act reporting to the Washington State Department of Ecology. Generation output used in the calculations are those resources over the period that were bid into EIM.
- b. 0 MWh, as Avista is not a participant in EDAM.
- c. 0 MWh, as Avista is not a participant in Markets+.
