On April 15, 2003, the Washington Utilities and Transportation Commission (Commission) filed with the Code Reviser a Preproposal Statement of Inquiry (CR-101) to consider revisions to WAC 480-100-238, "Least-cost planning." The CR-101, as filed with the Code Reviser, is available for inspection on the Commission's web site at www.wutc.wa.gov/030311. The review of WAC 480-100-238, "Least-cost planning," is part of the Commission's overall review of its rules. While the Commission recently reviewed Chapter 480-100, "Electric Companies," WAC 480-100-238 was deferred from that review of Chapter 480-100 WAC for further study pending the availability of sufficient resources. The Commission intends to conduct the review at this time. Consequently, WAC 480-100-238 will be reviewed for content and readability, with attention to the rule's need; effectiveness and efficiency; clarity; intent and statutory authority; coordination; cost; and fairness. The review will also consider whether the current rule has achieved its intended results, and whether it is consistent with Commission policies and advances in technology.

Subjects included in this review may cover but are not limited to:

- the roles of risk and uncertainty in resource planning,
- the role of demand management,
- the role of resource diversity, resource adequacy, and financial and physical hedging,
- planning issues, such as planning horizons and filing deadlines,
- portfolio analysis,
- rule process and enforcement issues,
- the relationship of least-cost plans to Commission review of specific generation or demand response projects,
- the relevance of any changes in policies or requirements at the federal and state levels, and
- appropriate uses of least-cost plans.
