On September 3, 2003, the Washington Utilities and Transportation Commission (Commission) filed with the Code Reviser a Preproposal Statement of Inquiry (CR-101) to consider revisions to the Commission's rules relating to minimum regulatory fees for class 1 utilities and transportation industries, except motor freight carriers. This rulemaking would also consider developing a rule that would address regulatory fees for railroads.
