

IMPORTANT NOTICE

June 28, 2004

Marbello Water Company, Inc. has filed for approval from the Washington Utilities and Transportation Commission for an increase in basic service rates.

The filing is expected to generate approximately \$101,500.00 in revenues. This is an increase of approximately 260 percent over 2003 revenues. The base rate increases from \$32.85 to \$43.37 per month. The usage rate is now assessed on all usage. There is no usage allowance in the base rate. The usage rate decreases from \$4.00 per 100 cubic feet to \$1.84 per 100 cubic feet.
