## NOTICE OF OPPORTUNITY TO FILE WRITTEN COMMENTS (By Wednesday, August 25, 2004)

RE: Rulemaking to Review WAC 480-70-401, Payment Options, and WAC 480-70-396, Billing, of Chapter 480-70 WAC Docket No. TG-041349

## TO INTERESTED PERSONS:

On August 4, 2004, the Washington Utilities and Transportation Commission (Commission) filed with the Code Reviser a Preproposal Statement of Inquiry (CR-101) to consider the amendment of rules relating to payment options and electronic billing procedures to allow solid waste/refuse collection companies and their customers more options for billing and payments. The CR-101, as filed with the Code Reviser, is available for inspection on the Commission's web site at <a href="http://www.wutc.wa.gov/041349">www.wutc.wa.gov/041349</a>. If you are unable to access the Commission's web page and would like a copy of the CR-101 mailed to you, please contact the Records Center at (360) 664-1234.

The Commission recently granted exemptions from WAC 480-70-401, Payment options, to five solid waste companies. The effect of the exemption is to allow the companies to accept customer payments in electronic form and, with the customer's consent, to send bills to customers in electronic form.

For purposes of illustration, the Commission encourages stakeholders to consider and provide comment on the rules for billing and payment that apply to telecommunications companies:

• **Bills** – "With the consent of the customer, a company may provide regular billings in electronic form if the bill meets all the requirements of this rule. The company must maintain a record of the customer's request, and the customer

**Payments** – "(a) Companies must, at a minimum, allow the following methods of payment: Cash, certified funds (e.g., cashier check or money order), and personal checks. (b) Upon written notice to a customer, companies may refuse to accept personal checks when that customer has tendered two or more nonsufficient-funds checks within the last twelve months." [WAC 480-120-161(8)]

# **STAKEHOLDER COMMENTS**

The Commission will hear comments on the question of whether to propose rules and the specific draft proposal at its regularly scheduled Open Meeting on **Wednesday**, **September 8** at 9:30 a.m. in Olympia.
