The Moon Road crossing is and has been a convenient and a safe crossing for automobiles, persons and animals. Having this crossing has also been necessary when the railroad has the other crossing blocked for extended periods of time. Petitioner states that closure of this crossing/road will greatly reduce train conflicts. The alternative to closing this crossing, and having better visibility at the crossing is to simply require the trains to park a safe distance of at least 250' from the crossing.
