# NOTICE OF OPPORTUNITY TO FILE WRITTEN COMMENTS (By Friday, August 26, 2005)

RE: Rulemaking to Consider Possible Correction and Changes to Selected Rules in Chapter 480-93 WAC, Gas Companies - Safety. Docket No. PG-050933

### TO INTERESTED PERSONS:

On August 3, 2005, the Washington Utilities and Transportation Commission (Commission) filed with the Code Reviser a Preproposal Statement of Inquiry (CR-101) to consider possible corrections and changes to selected rules in Chapter 480-93 WAC, Gas Companies – Safety, specifically addressing WAC 480-93-005(18), WAC 480-93-017, WAC 480-93-178, WAC 480-93-200(1)(e), and WAC 480-93-200(6)(c). The CR-101, as filed with the Code Reviser, is available for inspection on the Commission's web site at <u>www.wutc.wa.gov/050933</u>. On May 5, 2005, the Washington Utilities and Transportation Commission completed a comprehensive review of its safety rules relating to natural gas pipeline operations. The safety rules in Chapter 480-93 WAC took effect on June 2, 2005. In the process of implementing these rules, stakeholders and agency staff have identified several concerns with the rules listed above. While these provisions seemed clear at the time they were drafted, they do not appear as clear now. This rulemaking will consider revisions to the specific rules identified above. The rulemaking will not address any major policy changes to the recently adopted rules.

### WRITTEN COMMENTS

Because this rulemaking addresses corrections or clarifications to recently adopted rules, and not major policy changes, the Commission requests comments only in writing. Written comments addressing: proposed changes to WAC 480-93-005(18), WAC 480-93-017, WAC 480-93-178, WAC 480-93-200(1)(e), and WAC 480-93-200(6)(c) and any other rules in Chapter 480-93 WAC for which stakeholders request clarification must be filed with the Commission no later than <u>Friday, August 26, 2005</u>.

The Commission requests that comments be provided in electronic format to enhance public access, for ease of providing comments, to reduce the need for paper copies, and to facilitate quotations from the comments.
