Purpose of the proposal and its anticipated effects, including any changes in existing rules:

The purpose of this rulemaking is to correct a production error in a prior rule adoption in 2005. The effect of the error was to eliminate a provision that exempted telecommunications, gas, electric, and water chapters from the requirement to pay regulatory fees on de minimus revenue amounts, which was defined as less than \$20.

This rulemaking will correct the error by restoring the *de minimus* exemption that had been in effect prior to the

2005 adoption error.
