1. The Commission finds good cause to support the request and authorize the proposed changes to become effective with Less Than Statutory Notice on: March 1, 2006.

3. The temporary .10% fuel surcharge in all rates and charges is the result of increased fuel costs incurred by the company during the months of December 2005 and January 2006, to be collected from customers as follows:

For customers who are billed monthly for services in arrears, the fuel surcharge applies to all services provided in the months of March and April 2006.

Customers who are billed bi-monthly for services – one month in arrears and the current month:

The surcharge will appear on the April 1, 2006, billing and applies to all services provided in the months of March 2006, and April 2006.
