- Note 2: Rates named in this item apply for all hauls not exceeding 10 miles from the point of pickup to the disposal site. Excess miles will be charged for at \$2.50(A) per mile or fraction of a mile. Mileage charge is in addition to all regular charges.
- Note 3: Permanent Service is defined as no less than scheduled, once a month pickup, unless local government ordinances require more frequent service or unless putrescibles are involved.
