1. The Commission finds good cause to support the request and authorize the proposed changes to become effective with Less Than Statutory Notice on: December 1, 2006.

3. The temporary .76% fuel surcharge in all rates and charges is the result of increased fuel costs incurred by the company during the months of September and October 2006, to be collected from customers as follows:

For customers who are billed monthly for services in arrears, the fuel surcharge applies to all services provided in the months of December 2006 and January 2007. & February 2007

Customers who are billed bi-monthly for services -current month and one month ahead:

The surcharge will appear on the December 2006, billing to all services provided in the months of December 2006, and January 2007, and in the January 2007 to all services provided in the months of January 2007 and February 2007.
