For customers on automated service routes: The company will assess roll-out charges where, due to circumstances outside the control of the driver, the driver is required to move an automated cart or toter more than 25 feet in order to reach the truck. The charge for this roll-out service is: \$2.08(R) per cart or toter, per pickup.
