3. The temporary .56% fuel surcharge in all rates and charges is the result of increased fuel costs incurred by the company during the months of December 2006 and January 2007, to be collected from customers as follows:

For customers who are billed monthly for services in arrears, the fuel surcharge applies to all services provided in the months of March and April 2007.

Customers who are billed bi-monthly for services – one month in arrears and the current month:

The surcharge will appear on the April 1, 2007, billing and applies to all services provided in the months of March 2007, and April 2007.
