1. The Commission finds good cause to support the request and authorize the proposed changes to become effective with Less Than Statutory Notice on: September 1, 2007.

3. The temporary .98% fuel surcharge in all rates and charges is the result of increased fuel costs incurred by the company during the months of June 2007 and July 2007, to be collected from customers as follows:

Customers who are billed bi-monthly for services – one month in arrears and the current month:

The surcharge will appear on the October 1, 2007, billing and applies to all services provided in the months of September 2007, and October 2007.
