ORDER

1. The Commission finds good cause to support the request and authorize the proposed changes to become effective with Less Than Statutory Notice on: October 1, 2007.
2. The proposed changes will expire on: January 1, 2008.
3. The temporary 1.31% fuel surcharge in all rates and charges is the result of increased fuel costs incurred by the company during the months of July 2007 and August 2007, to be collected from customers as follows:

For customers who are billed monthly for services in arrears, the fuel surcharge applies to all services provided in the months of October 2007 & November 2007.

Customers who are billed bi-monthly for services -current month and one month ahead:
The surcharge will appear on the October 2007 billing and applies to all services provided in the months of October 2007 and November 2007 and in the November 2007 billing to all services provided in the months of November 2007 and December 2007.
