1. The Commission finds good cause to support the request and authorizes the proposed changes to become effective with Less Than Statutory Notice on: August 1, 2008.

3. The temporary 0.96% fuel surcharge in all rates and charges is the result of increased fuel costs incurred by the company during the months of April, May and June 2008, to be collected from customers as follows:

For customers who are billed monthly for services in arrears, the fuel surcharge applies to all services provided in the months of August, September and October 2008.

Customers who are billed quarterly for services – one month in arrears and two months in advance:
