Proposed changes are to add a Special Fuel Surcharge Supplement No. 18 in the amount of 7.06%.

Customers who are billed bi-monthly for services –current month and one month ahead:

The surcharge will appear on the October 2008, billing and applies to all services provided in the months of October 2008, and November 2008.
