1. The Commission finds good cause to support the request and authorize the proposed changes to become effective with Less Than Statutory Notice on: November 1, 2008.
2. The proposed changes will expire on: March 30, 2009.
3. The temporary 2.89% fuel surcharge in all rates and charges is the result of increased fuel costs incurred by the company during the months of July, August & September 2008, to be collected from customers as follows:

For customers who are billed monthly for services in arrears, the fuel surcharge applies to all services provided in the months of November, December of 2008 & January 2009.

Customers who are billed quarterly for services – one month in arrears, current and one month in advance:
