Description of amendment: reciprocal compensation

The amendment amends an adopted interconnection agreement that the Commission accepted on October 8, 2008 in Docket No. UT-083045. The adopted agreement was originally approved by the Commission on July 26, 2006 in Docket No. UT-063046 between Company and A and Company C, Ymax Communications Corp.

Company A represents that the amendment does not discriminate against non-party carriers, that it is consistent with state and federal law, and that it is in the public interest. By virtue of Company B's signature on the amendment, Company A believes that Company B agrees with these representations.
