A. PARTIES OF THE AGREEMENT

This project grant agreement (agreement) is entered into between the Washington Utilities and Transportation Commission (UTC), P.O. Box 47250, Olympia, Washington 98504-7250 and Puget Sound and Pacific Railroad, 510 N. 2nd Street, Elma, Washington 98541, and shall be binding upon the agents and all persons acting by or through the parties.

B. PURPOSE OF THE AGREEMENT

This agreement sets out the terms and conditions by which grants are made from the Grade Crossing Protective Fund. These grants are administered by the UTC to the grantee for Docket No. TR-091352, identified above.

C. <u>DESCRIPTION OF PROJECT</u>

TR-091352 involves upgrading obsolete train detection to current motion sensor technology. The crossing is identified as USDOT 096564A and located at Cole Road and Puget Sound and Pacific Railroad's tracks in Mason County, Washington.

D. PERIOD OF PERFORMANCE

The project reimbursement period shall begin on September 9, 2009, and end January 31, 2010. No expenditure made before or after this period is eligible for reimbursement unless incorporated by written amendment into this agreement.

E. PROJECT FUNDING

Total grant funding awarded by the UTC for these projects shall not exceed \$11,362.21. The total approximate cost of the project is \$12,706.21. The grantee shall be responsible for all labor costs.

All rights and obligations of the parties to this agreement are subject to this agreement and its attachments, including the grantee's application, commission orders, and the general provisions, all of which are attached and incorporated into this agreement.
