BACKGROUND

- 1 On September 14, 2009, Columbia Basin Railroad (Columbia Basin or Petitioner) filed with the Washington Utilities and Transportation Commission (Commission), a petition seeking approval to modify active warning devices at a railroad-highway grade crossing. The crossing is identified as USDOT 396980F and is located at the intersection of Alder Street and the Petitioner's tracks in the City of Moses Lake. The Petitioner further requested the Commission authorize an expenditure of \$8,316 from the Grade Crossing Protective Fund (GCPF) to pay for a portion of the upgrades.
2 Railroad warning devices at the intersection of Alder Street and the Petitioner's tracks in Moses Lake, Washington consist of cantilever mounted eight inch flashing lights. The Petitioner proposes to replace the obsolete eight inch flashing lights with 12 inch style LED type lights. These upgrades will improve the overall safety at the crossing because LED flashing lights will provide greater visibility for the motoring public.
3 The Petitioner is requesting a disbursement of \$8,316 to pay for a portion of the upgrades. The total approximate cost of the project is \$8,316. Columbia Basin will cover labor costs for installation. An expenditure of \$8,316 from the Grade Crossing Protective Fund is available to help fund the improvements.

FINDINGS AND CONCLUSIONS

- 4 (1) The Washington Utilities and Transportation Commission is an agency of the State of Washington having jurisdiction over public railroad-highway grade crossings within the state of Washington, and authority to approve and administer

disbursements from the Grade Crossing Protective Fund. *RCW 81.53;*  
*RCW 81.53.271; RCW 81.53.281.*

- 5 (2) The grade crossing at the intersection of Alder Street and the petitioner's tracks in  
Moses Lake, Washington, identified as USDOT 396980F, is a public railroad-  
highway grade crossing within the state of Washington.
- 6 (3) RCW 81.53.261 requires the Commission grant approval prior to any changes to  
public railroad-highway grade crossings within the state of Washington. *See also*  
*WAC 480-62-150.*
- 7 (4) RCW 81.53.271 allows the Commission to disburse up to \$20,000 from the Grade  
Crossing Protective Fund to pay for the installation of a grade crossing protective  
device, without requiring the Petitioner to share the cost.
- 8 (5) Commission Staff investigated the petition and recommended that it be granted,  
subject to specified conditions.
- 9 (6) After reviewing Columbia Basin's petition filed on September 14, 2009, and  
giving due consideration to all relevant matters and for good cause shown, the  
Commission grants the petition and request for disbursement of funds.

## ORDER

### THE COMMISSION ORDERS:

10 Columbia Basin Railroad's petition to upgrade warning devices at a railroad-highway  
grade crossing, located at the intersection of Alder Street and the petitioner's tracks in  
Moses Lake, Washington, is granted. The cost of this upgrade shall be paid from the  
Grade Crossing Protective Fund. Approval of the petition is subject to the following  
conditions:


- (1) Expenditure from the Grade Crossing Protective Fund must not exceed  
\$8,316.
- (2) Payment will be made upon presentation of claim for reimbursement  
for materials and labor, and verification by Commission Staff that the  
work has been satisfactorily completed.

- (3) Columbia Basin Railroad must sign and return the attached project agreement.
- (4) The project must be completed no later than May 31, 2010.
- (5) Traffic control devices must comply with all applicable standards specified in the U.S. Department of Transportation *Manual on Uniform Traffic Control Devices*.
- (6) Columbia Basin Railroad must notify the Commission on completion of the upgrades authorized in this Order. Acceptance of the upgrades is subject to inspection by Commission Staff, and verification that the crossing is in full compliance with applicable laws, regulations, and the conditions specified in this Order.

The Commissioners, having determined this Order to be consistent with the public interest, directed the Secretary to enter this Order.

**PROJECT AGREEMENT  
GRADE CROSSING PROTECTIVE FUND**

Commission Approval Date: September 23, 2009

**A. PARTIES OF THE AGREEMENT**

This project grant agreement (agreement) is entered into between the Washington Utilities and Transportation Commission (UTC), P.O. Box 47250, Olympia, Washington 98504-7250 and Columbia Basin Railroad, 111 University Parkway, Suite 200, Yakima, Washington 98901, and shall be binding upon the agents and all persons acting by or through the parties.

**B. PURPOSE OF THE AGREEMENT**

This agreement sets out the terms and conditions by which grants are made from the Grade Crossing Protective Fund. These grants are administered by the UTC to the grantee for Docket No. TR-091496, identified above.

**C. DESCRIPTION OF PROJECT**

TR-091496 involves replacing obsolete eight inch flashing lights with 12 inch style LED type lights. The crossing is identified as USDOT 396980F and located at Alder Street and Columbia Basin Railroad's tracks in Moses Lake, Washington.

**D. PERIOD OF PERFORMANCE**

The project reimbursement period shall begin on September 23, 2009, and end May 31, 2010. No expenditure made before or after this period is eligible for reimbursement unless incorporated by written amendment into this agreement.

**E. PROJECT FUNDING**

Total grant funding awarded by the UTC for this project shall not exceed \$8,316. The total approximate cost of the project is \$8,316. The grantee shall be responsible for all labor costs.

**F. RIGHTS AND OBLIGATIONS**

All rights and obligations of the parties to this agreement are subject to this agreement and its attachments, including the grantee's application, commission orders, and the general provisions, all of which are attached and incorporated into this agreement.

Except as provided, no alteration of any of the terms or conditions of this agreement will be effective unless provided in writing. All alterations must be signed by both parties.

The grantee has read, fully understands and agrees to be bound by all terms and conditions in these documents.

**G. COMPLIANCE WITH APPLICABLE STATUTES, RULES, AND UTC POLICIES**

This agreement is governed by, and the grantee shall comply with, all applicable state and federal laws and regulations, including RCW 81.53.281, the published agency rules in 480-62 WAC, and the commission's order in this matter which are incorporated by this reference as if fully set forth.
