PROJECT AGREEMENT GRADE CROSSING PROTECTIVE FUND

A. PARTIES OF THE AGREEMENT

This project grant agreement (agreement) is entered into between the Washington Utilities and Transportation Commission (UTC), P.O. Box 47250, Olympia, Washington 98504-7250 and Pend Oreille Valley Railroad, 1981 Black Road, Usk, Washington 99180, and shall be binding upon the agents and all persons acting by or through the parties.

B. PURPOSE OF THE AGREEMENT

This agreement sets out the terms and conditions by which grants are made from the Grade Crossing Protective Fund. These grants are administered by the UTC to the grantee for Docket No. TR-091657, identified above.

C. DESCRIPTION OF PROJECT

TR-091657 involves replacing the obsolete incandescent lights with LED type lights, replace system batteries, chargers, and the cross-bucks. The crossing is identified as USDOT 399650K and located at the intersection of State Route 31 and Pend Oreille Valley Railroad's tracks in Pend Oreille county, Washington

D. PERIOD OF PERFORMANCE

The project reimbursement period shall begin on October 27, 2009, and end June 30, 2010. No expenditure made before or after this period is eligible for reimbursement unless incorporated by written amendment into this agreement.

E. PROJECT FUNDING

Total grant funding awarded by the UTC for these projects shall not exceed \$20,000. The total approximate cost of the project is \$10,491.55. The grantee shall be responsible for all additional costs.

F. RIGHTS AND OBLIGATIONS

All rights and obligations of the parties to this agreement are subject to this agreement and its attachments, including the grantee's application, commission orders, and the general provisions, all of which are attached and incorporated into this agreement.

Except as provided, no alteration of any of the terms or conditions of this agreement will be effective unless provided in writing. All alterations must be signed by both parties.

The grantee has read, fully understands and agrees to be bound by all terms and conditions in these documents.
