**TRACFONE WIRELESS, INC.'S SECOND AMENDMENT TO PETITION FOR DESIGNATION AS AN ELIGIBLE TELECOMMUNICATIONS CARRIER**

TracFone Wireless, Inc. ("TracFone"), by its undersigned counsel, hereby amends its Petition for Designation as an Eligible Telecommunications Carrier ("ETC") in the State of Washington to clarify its Lifeline service area. By this amendment, TracFone clarifies that it will offer Lifeline service in all areas in Washington that are served by AT&T Mobility and T-Mobile. In the second quarter of 2010, TracFone will expand its Lifeline service area to include the areas in Washington served by Verizon Wireless. TracFone requests ETC designation statewide in all exchanges to the extent that its underlying carriers, including Verizon Wireless, have facilities and coverage.
