Re: Rulemaking to Consider Revisions to WAC 480-120-264(5)(a) Prepaid Calling [Card] Services, Docket UT-100148

TO ALL INTERESTED PERSONS:

On February 17, 2010, the Washington Utilities and Transportation Commission (Commission) filed with the Code Reviser a Preproposal Statement of Inquiry (CR-101) to consider the need to implement additional consumer protection disclosures in WAC 480-120-264(5)(a), the Prepaid Calling [Card] Services rule.

The Commission requests that interested persons provide written comments addressing specifically, whether the Commission should add new subsections to WAC 480-120-264(5)(a), as follows:

(vii) The disclosure of rates, terms, and conditions must be made in the language in which the card is advertised.

(viii) The number of minutes contained on the card must be disclosed on the card or its packaging.

The Commission also requests additional information to the extent that either of these potential changes will cause additional costs on any regulated company. If the additional

cost is considered minor then no comment is necessary. Otherwise, specific cost data is requested.

WRITTEN COMMENTS

Written comments addressing the questions listed above must be filed with the Commission no later than 5:00 p.m., Monday, March 22, 2010. The Commission requests that comments be provided in electronic format to enhance the public access, for ease of providing comments, to reduce the need for paper copies, and to facilitate quotations from the comments.
