1. The Commission finds good cause to support the request and authorize the proposed changes to become effective with Less Than Statutory Notice on: **July 1, 2011**.

3. The temporary **.54%** fuel surcharge in all rates and charges is the result of increased fuel costs incurred by the company during the months of **April** and **May** 2011, to be collected from customers as follows:

For customers who are billed monthly for services in arrears, the fuel surcharge applies to all services provided in the months of **July 2011** and **August 2011**.
