Proposed changes are to add a Special Fuel Surcharge Supplement No. 4 in the amount of 2.49%.

3. The temporary 2.49% fuel surcharge in all rates and charges is the result of increased fuel costs incurred by the company during the months of June 2011 and July 2011, to be collected from customers as follows:
