The possibility that it may be more convenient for this customer to write one check for biomedical services at various locations is not a factor in a grant of temporary authority, and certainly does not establish an "immediate or urgent need." Applicant has every right to serve customers within its currently permitted area, and apparently has at least one. That does not translate into a compelling need for temporary (or even permanent) statewide authority.

WHEREFORE, this Application should be denied as failing to even approach meeting the regulatory requirements for temporary authority.
